### CONDITIONS OF TRADING

These conditions of sale apply to the sale of plants by Brocklands Pty. Ltd. trading as CleanGROW pursuant to an order placed by buyers of such plants.

### NON-PROPAGATION AGREEMENT

1. I understand that varieties of plants indicated as protected varieties are protected varieties.
2. I Further understand that these varieties are purchased solely for the production of cut flowers and that propagation of these varieties is strictly prohibited.
3. I agree not to sell, lease, lend or give away varieties protected by this agreement and to notify CleanGROW should any mutations occur.

### TERMS AND CONDITIONS OF TRADE

1. Where a period for delivery is specified, the buyer shall take delivery within that period **provided** that any time for delivery given by CleanGROW is only by way of estimate and shall not be liable for any delay in delivery after such time or date.
2. The plants shall be delivered by CleanGROW in accordance with the buyer's instructions **provided** nevertheless that from the time of dispatch from CleanGROW's nursery and until such delivery, the risk of any loss or damage to or deterioration of the plants from whatever cause arising, shall be borne by the buyer.
3. The description of the plants has been given by way of identification only, and the use of such description shall not constitute a contract of sale by way of description
4. With regard to an order, CleanGROW reserves the right to substitute what are, in its opinion, suitable varieties of the same type of plant unless requested not to substitute on the order form.
5. All orders are accepted subject to plants being available from CleanGROW's stocks as at the delivery date.
6. All Prices are subject to alteration without notice.
7. Payment terms are 20% deposit, balance before delivery, until credit arrangements have been made. Accounts are only offered to established customers and are subject to a credit application being accepted. A book-keeping charge of 2% per month will be made on all overdue accounts.
8. Whilst every effort is made by c to ensure that plants are of the highest quality, and free from pests and /or disease, no warranty is given (expressed or implied) by CleanGROW:
  - a. as to the quality of the plants;
  - b. as to the productivity of the plants;
  - c. that the plants are free from pests and disease.**and** it is hereby declared that except as herein provided or as required by law all warranties and condition attaching to the sale of plants are hereby expressly excluded.
9. Any liability of CleanGROW is limited to the buyer and to the value of the plants at the date of the buyer's order. It shall not be liable for any consequential loss or damage.
10. These conditions may only be varied by the agreement in writing of CleanGROW and the buyer.

Minimum quantity is 100 plants per variety. Minimum order is 500 plants. Plants are available only as rooted – unrooted cuttings are not available.

**Freight:** Plants are dispatched by Australian air Express for collection at airport, our road carrier or Express Post. Other carriers on request plus \$20 delivery.

**Payment:** A deposit of 20% is required with order. All plants must be paid for before delivery, unless credit arrangements have been made. Accounts are only offered to established customers and are subject to a credit application being accepted. A bookkeeping charge of 2% per month will be made on all overdue accounts.
